Deadline for La. Residents to Claim IRS Stimulus Check is Oct. 15



Thousands of Louisiana residents are leaving money on the table, according to the Internal Revenue Service (IRS). The IRS announced Thursday, Sept. 17 almost 160,000 people in Louisiana haven't claimed their stimulus checks. If you have not yet claimed your stimulus checks, you should receive a letter from the IRS letting you know you are still eligible to claim it. The deadline to apply for that check is Oct. 15.

The Internal Revenue Service's (IRS) "Get My Payment" tool guides citizens through a process where they can submit their social security number and personal bank account information. Click here to go to visit the IRS' website and use the "Get My Payment" tool.

That process allows citizens to receive payments more quickly, as delivering paper checks may not begin until May.

The IRS is not contacting anyone to collect personal or bank account information.

Calls, texts, emails, and official-looking postcards or printouts that suggest otherwise are scams.

Checks that appear to show an overpayment are also scams.

Biden Campaign, DNC Announce New Vote-By-Mail Features on IWillVote.com

On Monday, Sept. 14, the Joe Biden for President campaign and the Democratic National Committee (DNC) have announced new features on IWillVote.com – the DNC's voter participation website – that will help voters easily request and return their ballot by mail.

According to the campaign, the site will also help visitors learn important information about the voting process in their state as they make their plan to vote.

Previously, an individual could use the site to check or update their registration and find voting locations. The new user experience will also guide a voter through their best voting-by-mail option based on their state and county regulations, including:

Requesting a ballot online. A voter will be directed to their state's online vote-by-mail request form.

Requesting a ballot by email. A voter completes a vote-by-mail request form, including uploading a picture of their signature (where required), on com. The form is

automatically emailed to the state.

Printing and mailing their request. A voter completes a vote-

by-mail request form on com. The voter then prints, signs, and mails the request form to the state.

Requesting a prepaid return envelope: A voter completes a vote-by-mail request form on

com and requests a prepaid return envelope. The voter will then receive their completed request form via mail to sign and return in a prepaid return envelope.

Additionally, IWillVote.com has been updated with new state-specific voter education pages and resources – to help voters easily find their states' deadlines to vote by mail, early, or in person, as well as other important information about their states' voting process.

"How ever voters choose to cast their ballots, these updates to the IWillVote.com site provide the tools necessary to exercise their right to participate in our democracy and ensure our community's voice is heard in this critical election," said DNC National Press Secretary Brandon Gassaway.

"Our lives and our livelihoods are at stake this November, and we're doing everything in our power to ensure every voter has all the information they need to make a plan to vote and send Joe Biden and Kamala Harris to the White House," Gassaway declared.

Judge Blocks Postal Service Changes that Slowed Mail Delivery

SEATTLE — A U.S. judge on Thursday granted a request to temporarily block controversial Postal Service changes that have been accused of slowing mail nationwide, calling them "a politically motivated attack" ahead of the 2020 presidential election.

Judge Stanley Bastian in Yakima, Wash., said he was issuing a nationwide preliminary injunction against the USPS sought by 14 states that sued the Trump administration and the Postal Service.

The states, all led by Democratic attorneys general, challenged the Postal Service's so-called "leave behind" policy, where trucks have been leaving postal facilities on time regardless of whether there is more mail to load. They also sought to force the Postal Service to treat election mail as first-class mail.

The judge noted after a hearing that Trump had repeatedly attacked voting by mail by claiming that it is rife with fraud.

American voters are expected to vote by mail in record numbers this November because of the lingering COVID-19 pandemic. The states have expressed concern that delays might result in voters not receiving ballots or

registration forms in time.

"The states have demonstrated the defendants are involved in a politically motivated attack on the efficiency of the Postal Service," Bastian said, adding that the changes created "a substantial possibility many voters will be disenfranchised."

Postal Service spokesman Dave Partenheimer said in a statement that "there should be no doubt that the Postal Service is ready and committed to handle whatever volume of election mail it receives."

Following a national uproar, Postmaster General Louis DeJoy, a major donor to President Trump and to Republicans, announced he was suspending some changes — including the removal of iconic blue mailboxes in many cities and the decommissioning of mail processing machines. Other changes remained in place, however, and the states have asked the court to block them.

Led by Washington Attorney General Bob Ferguson, the states said the Postal Service made the changes without first bringing them to the Postal Regulatory Commission for public

Literacy is the foundation of learning; and as distinguished scholars in History and English, Drs. Henry and Thelma Cobb embodied the spirit of learning. Henry earned his Bachelor of Arts degree in History and English from Benedict College and went on to earn the Master and Doctor of Education degrees in American History and Educational Administration from Temple University. Proving to be his equal, Thelma earned her Bachelor of Science degree in English from Hampton University, followed by the Master of Arts degree in English from Hampton University. She earned the Doctor of Education degree from the University of Houston in Curriculum and Instruction with a minor in Multicultural Studies.

The illustrious couple embarked upon distinguished teaching careers at some of the nation's most notable HBCUs, including Tuskegee Institute and FAMU, before settling in as members of the faculty at Southern University and A&M College. As a scholar and noted historian, Henry was celebrated as one of the nation's premier teacher/lecturer of African American History. Thelma was a noted consultant on Women's Studies, Multicultural Education, Literacy, African American Literature and Ethnic Studies. She served as a tenured Professor at Southern for 30 years before retiring in 1989 and received designation as Professor Emeritus in English.

When Henry retired from the

University in 1991, he was honored and named as its first Distinguished Professor Emeritus. He was also the first Black American to teach at LSU when he served as the Special Lecturer for the university's first Negro History course in 1969.

What great accomplishments from this husband and wife dynamic duo! It is my hope that with this collection of English & African American Literature, and American & African American History, that your students will be enlightened by knowledge of their history that is far too often misconstrued or disregarded; and inspired by the depth and richness of the African American Culture.



At the hearing, Justice Department attorney Joseph Borson said slow-downs caused by the "leave behind" policy had gotten better

Gov. Edwards Adjusts Phase 3 Order to Extend Alcohol Sales By One Hour

BATON ROUGE, La. — Following discussions with restaurant and hospitality industry leaders, Gov. John Bel Edwards today altered his Phase 3 order to allow the on premises sale and consumption of alcohol until 11 p.m. at restaurants, casinos and bars in parishes that are eligible to opt in to reopen bars. However, all bars must still close by 11 p.m.

The Governor's order previously ended the sale or service of alcohol for on-site consumption at 10 p.m. as part of mitigation measures recommended by the White House and designed to reduce the spread of COVID-19 across the state. While bars re-

main closed for on-site consumption in some areas, in parishes with lower incidence of COVID, local government may opt in to open their bars. Four parishes that are eligible have opted in so far: Acadia, Jefferson Davis, St. Landry and Plaquemines.

"I had a productive discussion this week with several restaurateurs and the Louisiana Restaurant Association and agreed that allowing the sale and service of alcohol until 11 p.m. for on premises consumption was a meaningful change we could make to the Phase 3 order to benefit restaurants that may have later service. To be

consistent, my updated order will allow casinos and bars in parishes where they are allowed to be open to also serve alcohol for on-site consumption until 11 p.m. However, opened bars will still be required to close at 11 p.m.," Gov. Edwards said. "Limiting hours for alcohol consumption is designed to reduce the amount of higher risk behavior in the community. This change has been implemented in several states, including Colorado, and has also been recommended by the White House Coronavirus Task Force."

Louisiana Trust Launches Effort to Identify Former Rosenwald Schools Across State

BATON ROUGE, La. - In the early 20th century, a partnership between Booker T. Washington of the Tuskegee Institute and Julius Rosenwald, president of Sears & Roebuck, built thousands of schools for African American children in the rural areas of the South. Louisiana saw 442 of those 5400 school buildings constructed, with grants from Rosenwald and matching support from the local communities where they were built. Following desegregation, many of the schools were abandoned or demolished. The Louisiana Trust for Historic Preservation (LTHP) has launched a new effort to identify and document the locations of these historic buildings (as well as those that have been lost) throughout the state.

used and maintained as a church, a community center, or even as a residence stood a better chance of survival.

LTHP has since set up an educational and resource center on lthp.org to gather information and memories about these schools and those who used them. This online center has additional resources including links to a searchable database and guides from the National Trust for Historic Preservation. LTHP encourages former students, teachers, their descendants, local libraries, and school boards or others with a connection to a former Rosenwald School to share any photos or information about the building.

This effort began after a site visit with staff from the Claiborne Parish Library, where the former Mt. Olive Rosenwald School was identified and its condition assessed. Brian Davis, LTHP Executive Director, says, "Since the Louisiana Trust works in all 64 parishes, connecting building owners with the resources to preserve them, it makes sense to incorporate this project into our ongoing efforts to help insure that the buildings and their importance are not completely lost." Zoo and Greenwood Park. The first phase, estimated to cost between \$25 and \$35 million, involves moving the zoo's entrance from Thomas Road to a connection off of La. 19 where a new 30,000-square foot entry complex will be constructed. It will house a gift shop, and space for camps and party rentals. A separate facelift for the adjoining Greenwood Community Park to better integrate it with the zoo. It also expands on the park's landscape adding more trails, sporting fields and such recreational amenities as zip lines, a mini golf course and outdoor concert venue.

Our entire EBR City-Parish as a whole has gained momentum in the area of health and wellness. SPEAK IT INTO EXISTENCE

We all want to see good things happen in our lives, but many of us have no idea how to make those things come to pass. Some people think that the ability to attract anything good to themselves is out of their control, and that good luck randomly descends on only a few chosen individuals. However, luck has nothing to do with it. When we exercise our faith, we can actually bring something into existence merely by speaking the Word.

In the beginning, God brought creation into existence by the power of His spoken Word (Genesis 1:3-29). He confidently commanded, and literally created, something out of nothing. This is awesome, but many people don't realize they have the same power. God the Father gave this power to His Son (Matthew 28:18), who in turn transferred it to us when we became born again. "Behold! I have given you authority and power to trample upon serpents and scorpions, and [physical and mental strength and ability] over all the power that the

enemy [possesses]; and nothing shall in any way harm you" (Luke 10:19, AMPC).

The tongue can either be a blessing or a curse, and what we repeatedly declare can manifest in us as well as in others. We should be mindful of what we speak into our—and others'—lives. Ignorance of the authority of the spoken word can bring pain and suffering. "Death and life are in the power of the tongue: and they that love it shall eat the fruit thereof" (Proverbs 18:21). It's our choice whether we bring to life something evil or something good; we must speak life.

Louisiana Seafood Industry Struggling During Pandemic; Business Owners Hope to See Relief



BATON ROUGE, La. - Louisiana's commercial fishermen are struggling during the coronavirus pandemic, but they now have the option to apply for assistance from the CARES Act.

Reporters spoke with seafood businesses about how demand for the product has gone down.

Since the start of the pandemic, fewer people are eating out at local seafood restaurants. Restaurants are restricted on how many people can dine at once, meaning fewer people are eating those delicious seafood platters.

Fishermen who sell their catch to restaurants are feeling the pressure.

"I think the price has to

come down because if you don't have sales you can't just keep a price at a level that there's no sale for," says Al Sunseri who is the co-owner of P&J's Oyster Company.

Sunseri explains that business has been hard because restaurants are unable to operate at full capacity. So, fishermen aren't seeing a high demand for a crab, shrimp, or oysters.

However, local seafood restaurants are eager to get back to serving their full menu to normal size crowds.

"I want to see all restaurants do good. It going to 75% is great, but you...100% whenever everything is better. So, hopefully, that's soon... everybody will be at full

capacity. Everybody will be back doing good again," says Mike Anderson Jr. who owns Mike Anderson's Seafood.

The Louisiana Department of Wildlife and Fisheries (LDWF) is now stepping in to try and help these commercial fishermen secure funding made available from the CARES Act.

"Business is not up to par, so the industries have been having a hard time getting their products out to folks," says Jason Duet who is the biologist director for LDWF.

Struggling seafood businesses can apply to receive financial help from the CARES Act to keep them afloat until restaurants start serving more seafood.






